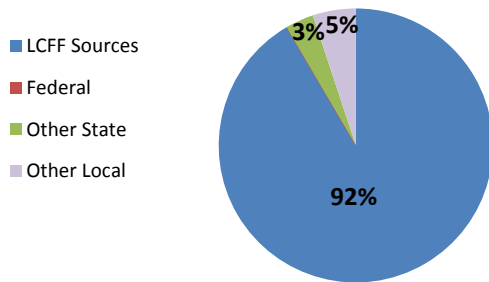
OVERVIEW

This report contains the 2014-15 Unaudited Actuals report for the Ripon Unified School District which consists of the State required SACS reports and supplementary schedules. The Unaudited Actuals summarizes the financial activity and reflects financial condition at the close of the fiscal year. This report is submitted to the San Joaquin County Office of Education and the California Department of Education for review. The Districts external auditor will review the financial report and issue the District Audit Report which will verify balances and statements.

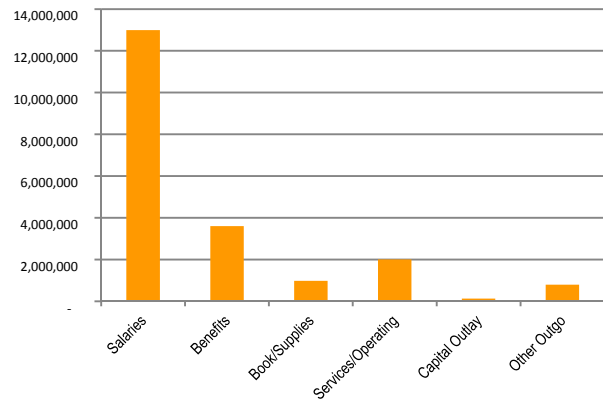
Revenue and Expenses

General Fund Revenues and Expenses reflect the majority of the District operational expenses. Revenues and Expenditures are classified as Unrestricted and Restricted. Unrestricted classifications include LCFF and unrestricted Lottery. Restricted classifications accounts for entitlements, grants and donations that must be used for a specific purpose as a condition of receipt of the funds.

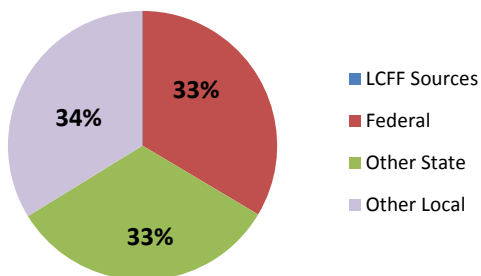
Unrestricted Revenue



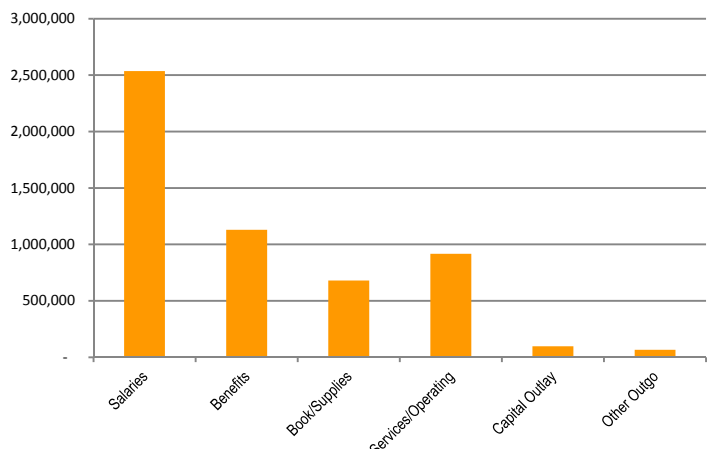
Unrestricted Expenses
