The one page document is still a template for what we plan to have in the three year plan.
- ii. Kathy C/Jodi went over goals and actions listed in the document
  - Comments: Kathy C will add RTELs to the goals and actions
  - Kathy discussed the difference between RTELs and LTELs: These titles put them into a category so the admins and teachers can put together a formula to help get the extra help they might need to continue to progress.
  - 3. How do parents feel about our programs for ELs: Adriana Ponce: has 3 students, 2 who were reclassified in 2nd grade and feels that they have done well and the Kinder loves Imagine Learning (supplemental online program)
  - Claudia Barajas: child is reclassified and wants to know how long they are monitored
    - a. 4 years so we can make sure that they don't slip and get overlooked
  - 5. Claudia Angel: 8th grader still EL, if she doesn't meet requirements and goes to HS, will it be a detriment to her?
    - a. We have EL classes in the HS, and it would be an elective
  - 6. Adriana Ponce: Aside from committees are there any other opportunities for parents to get involved. Or is everything on hold because of the pandemic?
    - a. We are still working on getting students back to school safely. But, we are working on how

- to implement a plan for more activities for parent involvement.
- 7. Kathy C: if we were able to find a teacher who would be willing to teach English classes via Zoom, would that be something parents would be interested in?
  - a. Claudia Barajas: would participate but can't speak for other parents
  - b. Adriana Ponce: would participate, but there were so many parents last time that couldn't read or write, let alone get on the computer. But it would be fine to try. Maybe now that there has been distance learning, that has improved.
  - c. Claudia Angel: In modesto, the district and college (maybe) is providing college courses to parents (via zoom) based on income. Seems like some of things happening in the other ESL classes, is that parents were at different levels, so it would be better to offer different levels.

  - ii. September 2 Tier III at two schools (SPED cohorts)

  - v. October 19 2 HS classes, Diesel Mechanics and Welding will return
  - vi. We are currently discussing a plan for 7-12 to return. We anticipate that you will hear something soon.

      - a. Kathy C: HS is more difficult because of the students transitioning between classes and unable to stay in one cohort. The two classes coming back will do only a few hours since there is nothing they can do online, then will

return to DL for the remainder of their class time.

- 2. Claudia Angel: any idea of how soon the HS will return?
  - a. Kathy C: does not know at this time. Return to school has been happening in phases as it is easier to manage small groups, admins can help students and teachers learn about the new procedures that need to take place in order to keep everyone safe. It is too hard to speculate how things will progress as the different grades are returning.
