- 1. Welcome/Introductions

- 5. ELPAC Initial testing: Informative video played to help everyone understand the ELPAC process and score reports.
  - Moving forward the previous years results will be on the current years report.
- 6. Reclassification process: Suzette showed a slide that breaks down the requirements for reclassification. Students are assessed using at must meet threshold requirements for ELPAC, CAASPP, STAR 360 & Aimsweb. Teacher or admin can classify a student "not ready" and will provide the rationale and evidence. Parent input also has the ability to determine if a student does or does not get reclassified.
  - We are working on getting the teachers involved in the process of what is needed for reclassification and to also encourage the students to take the ELPAC very seriously because it is a huge part of their reclassification.
  - Suzette discussed how in the District's LCAP each site is going to be identifying the long term English learners and get them an onsite mentor.

There were no questions or concerns regarding the reclassification process. DELAC members agreed with the current criteria for the reclassification process.
